On July 31, 2015, Governor Terry Branstad received a Presidential Disaster Declaration designating 19 counties in Iowa.

This declaration initiates availability of federal funding to assist the designated counties in recovery from major damage and debris caused by the severe storms, tornadoes, straight-line winds, and flooding that occurred during the incident period identified above.

Additional counties may yet be designated following further evaluation. Federal assistance is presently available within the counties listed below, from each respective program for which a county is designated.

PROGRAM NAME Public Assistance: Assistance to State and local governments for the repair or replacement of disaster damaged public facilities, and to offset extraordinary costs incurred in the removal of debris generated by the event and the performance of emergency protective measures in response to the event.
