**PROCLAMATION OF DISASTER EMERGENCY  
EXTENSION**

- WHEREAS,** ON SUNDAY MAY 25, 2008 AND CONTINUING, SEVERE STORM SYSTEMS MOVED ACROSS PORTIONS OF IOWA; AND
- WHEREAS,** STORMS HAVE RESULTED IN WIDESPREAD FLOODING AND DESTRUCTION TO AREAS IN IOWA; AND
- WHEREAS,** ON MAY 25, 2008, I ISSUED MY ORIGINAL PROCLAMATION OF DISASTER; AND
- WHEREAS,** ON JUNE 24, 2008, I ISSUED A THIRTY-DAY EXTENSION OF THE ORIGINAL PROCLAMATION OF DISASTER; AND
- WHEREAS,** ON JUNE 18, 2008, I ISSUED A PROCLAMATION EXTENDING THE DEADLINE FOR TAXPAYERS AFFECTED BY FLOODING OR TORNADOS WHO RESIDE OR HAVE A BUSINESS IN THE STATE OF IOWA AND HAVE RETURNS AND PAYMENTS DUE AFTER MAY 24, 2008 AND BEFORE JUNE 26, 2008; AND
- WHEREAS,** PURSUANT TO CHAPTERS 422, 423, 423A, 423B, 423C, 423D, 423E, 424, 450, 450A, 450B, 452A, AND 453A OF THE IOWA CODE, TAXPAYERS NORMALLY MUST FILE TAX RETURNS AND MAKE PAYMENTS FOR TAXES THAT ARE DUE BETWEEN MAY 25, 2008 AND JULY 23, 2008; AND
- WHEREAS,** DUE TO THE ONGOING DISASTER EMERGENCY, MANY TAXPAYERS REMAIN UNABLE TO FILE TAX RETURNS AND MAKE PAYMENTS FOR TAXES DUE BETWEEN MAY 25, 2008 AND JULY 23, 2008.

**NOW, THEREFORE, I, CHESTER J. CULVER, GOVERNOR OF THE STATE OF IOWA, BY THE POWER AND AUTHORITY VESTED IN ME BY THE CONSTITUTION ARTICLE IV, SECTIONS 1 AND 8 AND IOWA CODE SECTION 29C.6(1), DO HEREBY DECLARE THE FOLLOWING MEASURES:**

1. PURSUANT TO IOWA CODE SECTION 29C.6(6), I DO HEREBY EXTEND THE DEADLINE FOR TAXPAYERS AFFECTED BY FLOODING OR TORNADOS WHO RESIDE OR HAVE A BUSINESS IN THE STATE OF IOWA AND HAVE RETURNS AND PAYMENTS DUE AFTER MAY 24, 2008 AND BEFORE JULY 23, 2008.
2. THESE RETURNS AND PAYMENTS FOR THE AFFECTED PERIODS OF TAXPAYERS AFFECTED BY FLOODING OR TORNADOS WILL NOT BE DUE UNTIL JULY 28, 2008.
3. NO PENALTY FOR FAILURE TO FILE RETURNS OR FAILURE TO MAKE PAYMENTS OR DEPOSITS WILL BE DUE FO THOSE RETURNS AND PAYMENTS DUE AFTER MAY 24, 2008 AND BEFORE JULY 23, 2008 IF THE RETURNS AND PAYMENTS OF TAXPAYERS AFFECTED BY FLOODING OR TORNADOS ARE FILED BY JULY 28, 2008. IN ADDITION, INTEREST WILL BE ABATED ON ANY PAYMENTS DUE AFTER MAY 24, 2008 AND BEFORE JULY 23, 2008 OF TAXPAYERS AFFECTED BY FLOODING OR TORNADOS IF THE PAYMENT IS MADE BY JULY 28, 2008.
