IN THE NAME AND BY THE AUTHORITY OF THE STATE OF IOWA

PROCLAMATION OF DISASTER EMERGENCY EXTENSION

- WHEREAS,** ON SUNDAY MAY 25, 2008 AND CONTINUING, SEVERE STORM SYSTEMS MOVED ACROSS PORTIONS OF IOWA; AND
- WHEREAS,** STORMS HAVE RESULTED IN WIDESPREAD FLOODING AND DESTRUCTION TO AREAS IN IOWA, CAUSING DAMAGES AND RELATED IMPACTS TO PRIVATE AND PUBLIC PROPERTY INCLUDING RESIDENCES, BUSINESSES, AND INFRASTRUCTURE; AND
- WHEREAS,** ON MAY 25, 2008, I ISSUED MY ORIGINAL PROCLAMATION OF DISASTER; AND
- WHEREAS,** THE RESULTING FLOODING CONDITIONS HAVE MADE AND WILL CONTINUE TO MAKE IT NECESSARY FOR PERSONS AND BUSINESSES IN IOWA TO MOVE ITEMS AND BELONGINGS FROM FLOODED AREAS; AND
- WHEREAS,** MANY SUCH PERSONS AND BUSINESSES ARE IN NEED OF TRAILERS TO ASSIST IN THE RESCUE AND PROTECTION OF ITEMS AND BELONGINGS FROM FLOODED AREAS AND AREAS THREATENED BY FLOOD ("FLOOD RELIEF"); AND,
- WHEREAS,** STRICT COMPLIANCE WITH THOSE PROVISIONS OF CHAPTER 321 OF THE IOWA CODE REGARDING TITLE AND REGISTRATION OF TRAILERS WILL PREVENT, HINDER OR DELAY FLOOD RELIEF EFFORTS; AND,
- WHEREAS,** SUCH FLOOD RELIEF EFFORTS ARE NECESSARY TO COPE WITH THE EMERGENCY PRESENTED BY SAID FLOODING AND CONTINUED FLOODING.


NOW, THEREFORE, I, CHESTER J. CULVER, GOVERNOR OF THE STATE OF IOWA, BY THE POWER AND AUTHORITY VESTED IN ME BY THE CONSTITUTION, ARTICLE IV, AND SECTIONS 1 AND 8 AND IOWA CODE SECTION 29C.6(1), DO HEREBY EXTEND THE FOLLOWING:

1. PURSUANT TO IOWA CODE SECTION 29C.6(6), I DO HEREBY SUSPEND THE REGULATORY PROVISIONS OF CHAPTER 321 OF THE IOWA CODE REGARDING TITLE AND REGISTRATION OF TRAILERS (AS DEFINED IN CHAPTER 321) FOR TRAILERS PURCHASED FOR THE PURPOSE OF FLOOD RELIEF EFFORTS.
2. ANY TRAILERS NOT TITLED OR REGISTERED ACCORDING TO THE REQUIREMENTS OF CHAPTER 321, PURSUANT TO THE AUTHORITY OF THIS PROCLAMATION, SHALL BE PROPERLY TITLED AND REGISTERED, ACCORDING TO AND AS REQUIRED BY THE REQUIREMENTS OF CHAPTER 321 OF THE IOWA CODE, WITHIN 30 DAYS OF THE EXPIRATION OF THIS PROCLAMATION.


THE DURATION OF THE SUSPENSION OF REGULATORY PROVISIONS PURSUANT TO IOWA CODE SECTION 29C.6(6) IN THE IMPACTED COUNTIES, AS SET FORTH ABOVE, SHALL REMAIN IN EFFECT THROUGH THE PERIOD OF TIME THAT THE DISASTER DECLARATION(S) REMAIN IN EFFECT FOR THE IMPACTED COUNTIES.
