EQIP offers financial and technical help to assist eligible participants install or implement structural and management practices on eligible agricultural land.

This program provides funds for the maintenance of crossing signals. The funding is calculated based on the number of crossings each railroad maintains.
	IA Department of Transportation (DOT)		State Grade Crossing Surface Repair Program	Provides annual \$900,000 appropriation from the Road Use Tax Fund to assist railroad companies and highway jurisdictions repair rail/highway grade crossings. The Grade Crossing Surface Repair Fund will pay 60 percent of the cost of repairs, with the responsible roadway jurisdiction and the railroad company each paying 20 percent.
	IA Department of Transportation (DOT)		Rail Assistance Program	This program is designed to enhance, restore, conserve or improve rail lines. Tracks are upgraded that have one train per day that serves places like grain elevators. The upgrading is designed for safety to avoid derailments.
	IA Department of Transportation (DOT)		Rail Economic Development Program	Projects under this program usually involve rehabilitation or construction of spur tracks needed to serve a new industry or improvement of facilities at an existing industry. A total of 60 projects have been funded since the program began in 1986. Over \$5 million has spent on these projects.

Many of the programs are based upon federal law administered by the US EPA. In these cases the federal government has delegated program responsibility to the DNR. In each case, permits and review of technical proposals are supplemented by assistance from staff to help local governments, businesses and individuals meet the requirements of state and federal law.
	IDNR		Emergency Response Unit	The Emergency Response Unit provides 24-hour technical assistance for response and remediation activities related to chemical spills and hazardous conditions. The Unit coordinates larger incidents in conjunction with field office staff. They also participate in the development of plans for regional response to emergencies, such as a spill on the Mississippi River.
	IDNR		Water Supply Section	The Water Supply Section of the Iowa Department of Natural Resources regulates public drinking water supplies in Iowa according to the federal Safe Drinking Water Act, under authority from the U.S. Environmental Protection Agency. A public water supply is defined in federal law as serving 25 or more people each day for at least 60 days out of the year, or having at least 15 connections. The purpose of the section is to ensure both the safety of the state's public drinking water supplies and the protection of the state's water resources.
	IDNR		Waste Water Section	The Wastewater Section issues both construction and operation permits. Permits are required for the construction of any municipal and industrial treatment and collection facilities that discharge treated wastewater to a river or stream. This section also reviews and issues permits for wastewater reclamation projects and non-discharging animal feeding operations. Wastewater permits are required for small on-site wastewater disposal systems that commonly serve developments or small areas in the treatment of domestic wastewater. Some larger cities have accepted delegation of responsibility for the review of sewer extensions.
	IDNR		Overview	The Water Resources Section has responsibilities for water quality and water quantity programs. Primary water quality responsibilities include setting state water quality standards, water quality monitoring and assessment, water quality modeling, providing state water quality certification for federal permits and licenses, and developing and implementing the state's nonpoint source pollution control program.
