New Business:

- 2007 Region 7 LEPC/TERC Conference: August 16-19, 2007, Hyatt Regency Crown Center, KC, MO.. Information is being e-mailed to Committee members as it is made available. Adam Broughton is very active on the planning committee for this event. The IERC has set aside \$7500 to assist LEPC members to attend.
- The IERC provides funding to the annual Hazmat Symposium through the HMEP grant. See if the IERC can get some recognition in the 2007 Hazmat Symposium (see Lisa for details of how much and how it is funneled to the Symposium. Kathy Lee will take this to the Symposium planning committee to see if the IERC can be recognized as a partner with the Symposium.
- HMEP Grant Program review – need volunteers for a short term committee. At the last meeting it was deferred to form a committee to review the way the HMEP is allocated and possibly tune the way the grant is allocated to LEPCs. One of the problems is money that is returned or released at the end of the grant period and then Lisa is scrambling to re-allocate it. Would like to do this on the front end so LEPCs will know what the new rules are. LEPC Application packets will go out in June. Still waiting to see if we will get an increase.

April 16-20 National Association of SARA Title III Program Officials (NASTTPO) meeting in Kansas City.- Lisa Sexton is going and could network with other states.

Old Business:

- IDSI –Tier II Managers / E-Plan – Background – Polk County demonstrated Tier II Manager system a year ago, tried to get funding through HMEP but was denied. HSEMD explored possibility to use re-allocated grant money to purchase. Several meetings and working with IWD. Long story short, chased the issue and why it is marketed, there are different levels of access and licenses. The cost was prohibitive to do what we wanted. E-Plan would be an alternative and Paul Sadler/Anne Jackson talked briefly about what they knew about it. IT would be free and a part of Tier II Submit and web based and accessible to First responders and county and state planners, which is what we were trying to accomplish with Tier II Manager. Lori Morrissey added that the IERC should move forward and making Tier II more accessible and useable. Right now it is a nightmare for LEPCs.

Business Community is very cooperative. Problem with Tier II submit is the File Maker part of it that makes it impossible to access and use.

- County Ordinances for Hazmat Cost Recovery – Kathy Lee a couple of counties had bills for cost recover and they contacted DNR to see if they would pay the

bill. She went to ISAC know about cost recovery and DNR feels that counties have the authority to have cost recovery and IEMA is suppose to send a letter. Suggest that HSEMD ask counties if they have a cost recovery ordinance when they submit their plans. HSEMD could not require the ordinance, but could conduct a poll. Involve Public Health.

- Committee membership re-appointments – Governor’s office is reviewing the Committee membership and desires to replace those who have been on all commissions for too many terms. Sue Lagneaux’s position requires Senate confirmation. It is likely her position will be replaced.

Agency Reports

Homeland Security and Emergency Management Division

Section 301 – LEPC membership – Appointments and Resignations. The list of resignation is spread on the minutes. Moved by Elizabeth Christiansen to accept the resignations, second by Sue Lagneaux. Motion carried unanimously.

LEPC Membership Report – as far as we know there are at least two members in each LEPC.

It was suggested that an article about needing LEPC membership updates be written in HSEMD newsletter. Lori suggested a LEPC handbook. Julie has one from another state.

Frank Magsamen requested the IERC membership list be sent to all IERC members.

Section 303 – Plan Submissions – all counties have current and compliant plans.

Section 305 – Training Funds and Courses – Change in Hazmat Techs course PER 0241. Bob Cox was the only one who responded and it was ok. He said that there is no state certification anyway.

Division of Labor

Section 302 & 312 – Tier II Reporting & facility Submissions

Totals for 2005 came in at 3139 facilities with 15202 chemicals and there are some blanks. They are working with DNR with Gale George and Pat McDermott in populating the database with GPS coordinates with 2006 data. Hopefully by this summer DNR will have that done. Paper forms for Tier II submittals for 2006 are way down. Electronic submittals are up.

Anne Jackson has provided the 2005 data to HSEMD for planning purposes in Excel format and it has been distributed to the HSMED planners.

Dept. of Natural Resources

Section 304 & Section 313 - Emergency Notifications & Form R Reporting
Kathy Lee reported on the running total of spills. December and January spills were significantly down and things were quiet, but things picked back up in February.

2006 was the lowest year since 1990 of 709 spills. The running average is 866 spills per year. She provided a hand-out of Spills Statistics substances and modes - 17 years of data. Kathy will send Paul a e-mail with the handout she provided. No Form R have been received - they are not due until July 1st.

Risk Management Program Grants

- ◆ The region is anticipating a Risk Management Grant Program similar to previous years. The anticipated total amount will be determined once the EPA's budget is set and the projected timeframe for the announcement is May with a 30-day application response time.

Local Government Reimbursement for Emergency Response

- ◆ Local Government Reimbursements (LGR) of up to \$25,0000 is available to cities, towns, townships, municipalities, parishes, counties, and recognized Indian Tribes. After an incident, complete the application and send it in. For more info visit: www.epa.gov/superfund/programs/er/lgr.

RMP Update

- ◆ EPA is working toward improving RMP electronic updating capabilities by increasing the number of items updated / corrected via the internet. The next step will allow facilities to add accidents to the accident history section. By 2009, the next major update cycle, the goal is for facilities to be able to complete the entire RMP via the internet.
- ◆ EPA hopes to have some Ag Fertilizer Retailer RMP guidance out this year.

LEPC Survey

- ◆ EPA Headquarters will be sending out a questionnaire, similar the one sent out few years ago to LEPCs. The purpose will be to assess the capabilities of LEPCs to prevent, prepare for, and respond to chemical emergencies. There should be an announcement in the Federal Register. The survey is planned to be internet based.

Computer-Aided Management of Emergency Operations (CAMEO) Update

- ◆ CAMEO enhancements are in the works. Planned enhancements include: adding fires and explosions to Aloha, adding a WMD module, web-based replacement for MARPLOT (chemical library & maps), and a new version of Landview in 2009.

Polychlorinated Biphenyls (PCBs) Transformer Database Update

- ◆ Includes information on the locations and owners of PCB transformers that have a concentration of greater than 500 parts per million.
- ◆ We are in the process of contacting those in the database to confirm transformer locations and that the fluid containing PCBs is still present.

TRI Update

- ◆ Expansion of eligibility for TRI reporters to use the Form A Certification Statement in lieu of the more detailed Form R was announced. This rule is intended to encourage shifts from emissions to preferred waste management practices such as recycling.
- ◆ TRI reports will continue to be required annually.
- ◆ Public release of 2005 data is anticipated to occur in late February / early March 2007.
- ◆ To provide information to the community faster and make the data compilation process more efficient, EPA encourages paperless submittals via the internet. Only the software (including the Form R instruction booklet and forms) will be sent to facilities.

Ethanol – EPA Region 7 developing manual consisting of environmental regulations relating to construction and operation. Going to Headquarters for review. Maybe available in next 3 to 6 months. Any public related brochures will come later. Lori - fire departments are looking for guidelines for planning and response. Dave Coppess asked if there were any changes for ethanol plants? Pat Reitz said she does not expect to see any changes.

The RMP Grant for facility inspection - In Iowa the program is with IDALS and the have a target of about 60 audit visits to RMP facilities. Don't know how many are completed but they are proactive and working with facilities. There has been some success in helping facilities to make changes to get back on track. Companies that have had IDALS visits have been responsive and very appreciative of the manner in the way the audits have been conducted and the assistance they have been getting.

Lori Morrissey asked what is the most recent RMP that LEPCs are suppose to have. They should have submitted them every 5 year. They are suppose to coordinate with their local responders. EPA can give LEPCs access to the RMP input database to get

the base information then contact Pat Reitz for specific ones for the worse case scenario. You also can go directly to the RMP facility and get that information.

Pat Reitz provided flyers on submitting TRI information, explaining that they may submit electronically.

FEMA Reports – no report – no representative.

Public Comment

- Lori Morrissey thanked Paul S. for producing the HazStat map again, which came out the first of January using 2004 data. It compiles information from Bureau of Labor and DNR. The last complete map was done in 1998.
- Governor's Homeland Security Conference. – still working on speakers.
- Julie Bell had been working with Madison County LEPC and thanked Paul Sadler and Lisa Sexton for getting the information she needed.
